## **GENERAL**:

This specification governs the technical requirements of a high strength synthetic rubber based contact adhesive. Adhesive contains combination of organic solvents. The adhesive has excellent resistance to moisture and provides excellent durability on exposure to elevated temperature.

# 2. APPLICATION:

For bonding of Cork gasket.

#### COMPLIANCE WITH NATIONAL STANDARDS 3.

#### 4. **SAMPLE FOR TEST:**

0.5 Kg, of sample shall be supplied for testing and approval.

#### 5. **SHELF LIFE:**

6 months in a sealed container kept in a cold (20° C) and dry place.

at 140°C for 4 hrs

6.4 Drying time at Room Temp. : Within ½ an hour after application by brush.

6.5 Flash Point

: 4° C, Min.
