### 1. Background

BHEL is manufacturing various types of electrical machines (Motors and Generators). In these machines various types of insulation tapes are required. These tapes are manufactured in running lengths. The width of roll is approximately 1 meter.

These rolls are slit into strips/tapes, ranging in thickness from 12.7mm to 25mm. These tapes are wound on the card board tubes.

#### 2. Purpose

Purpose of the card board tube is to, act as bobbin for various insulation tapes.

# 3. Requirement

Paper tubes made up of kraft paper/ board of minimum 22 BF and high (250 min) ply bond. Fine cutting shall be done to ensure burr free edges. De-lamination of layers of paper or board shall not occur.
