 - Pre-Despatch inspection & testing of material may be carried out at manufacturer or vendor works by BHEL representative. If pre-despatch inspection is not carried out at manufacturer or vendor works then testing and inspection will be done at our works' to ascertain the quality and results must be acceptable to supplier.
