1.0 GENERAL:

This specification governs the quality of Acrylic Resin Sheet i. e. Perspex, manufactured from polymethyl methacrylate.

2.0 APPLICATION:

Suitable for use as a glazing material where transparency, toughness and ease of working and repairing are of special value.

3.0 COMPLIANCE WITH NATIONAL STANDARDS:

There is no Indian Standard covering this type of material.
