NON - CONDUCTING POLYESTER FOAM STRIP

1. GENERAL :

This specification governs the technical requirements of Non-Conducting Polyester Foam Strip made of polyester fibres, bonded with polyacrylate and finished with polyurethane coating. The material shall be termite and bacteria proof and shall have good resistant to water, petrol, oil, grease, detergent etc. suitable for use at 110 deg.C, Max.

2. APPLICATION:

Used as packing material at slot bottom of electrical machines.

3. COMPLIANCE WITH NATIONAL STANDARDS :

There is no Indian Standard covering this material.

4. DIMENSIONS AND TOLERANCES :

4.1 Preferred Thickness: 1.10 mm with tolerance of ± 0.025 mm.

4.2 Preferred Width:

25, 30, 50 mm with a tolerance of ± 0.5 mm. However any other width can be ordered.

4.3 Length: A roll of 500 metre.

5. IDENTIFICATION: The material when identified by Infrared spectrometer or by any

other convenient method shall be polyester.

6. TEST METHODS: Unless otherwise specified, the tests shall be conducted in

accordance with the relevant methods of IS:5351.

SAMPLE FOR TEST :

2 sheets of required thickness in size 500x500 mm shall be sent for test and approval purposes.
